

PRIVACY POLICY

AMICIMI BVBA sees to your privacy and acts at all times in accordance with the provisions of the Belgian Privacy Act (Act of 8 December 1992 on the protection of privacy in relation to the processing of personal data). Please read this privacy statement to learn more about the manner in which personal data are collected and processed on this website.

1. Processing of personal details

By using the website www.amicimi.com and/or by entering into an Agreement with AMICIMI and/or by downloading/using the "AMICIMI app" and/or by communicating your personal details by means of an electronic or written document, you explicitly agree with the manner in which AMICIMI collects and processes the personal details, as described in this privacy statement.

When you visit the website www.amicimi.com, AMICIMI registers your IP address, your browser and operating system, the external website which referred you to this website, the pages visited by you on this website and that date and time on which you visited these pages. This information is only collected for statistical purposes and for the further improvement of this website.

Furthermore, AMICIMI registers every use you make of the "AMICIMI Panic button" and the manner in which the "AMICIMI Services" are terminated. This information is only collected for statistical purposes.

In addition, AMICIMI collects the information you provided when completing a contact form, when placing an order for the delivery of the "AMICIMI Panic button" and/or the provision of "AMICIMI Services" (electronically via the website www.amicimi.com or in writing), when creating your profile on the "AMICIMI app" or which subscribing for the newsletter. The audio recording made by your mobile phone as well as the GPS coordinates of your mobile phone, tracked by the "AMICIMI app", are collected as well.

AMICIMI exclusively uses the data communicated by you to deliver the information requested, to send the newsletters requested, to execute your order and thus to deliver the "AMICIMI Panic button" and/or the "AMICIMI Services", as described in the General Terms and Conditions, and/or to fulfil any other obligations resulting from the Agreement.

Non-sensitive personal details communicated by you can also be used for direct marketing purposes.

The data may be forwarded to our partner Securitas Alert Services NV, Sint-Lendriksborre 3, 1120 Brussels, within the context of the provision of the "AMICIMI Services".

In addition, AMICIMI is entitled to disclose your personal details to the competent authorities at their explicit request.

The data can also be processed by AMICIMI in a country outside the European Economic Area (EEA).

Please take into account the fact that the information posted by you in public places, e.g. comments on the discussion forum or on the blog, can be consulted by anyone.

2. Use of your personal details

AMICIMI uses your personal details exclusively for the above-mentioned purposes. In no case shall your personal details be sold or rented out to third parties. If you do not wish to receive newsletters or information about our products or services, you can unsubscribe at any time by sending AMICIMI an e-mail message.

AMICIMI takes all measures to safeguard the confidential nature of the information provided by you. However, you acknowledge that sending personal data via the internet is never without risks. You therefore acknowledge and accept that the losses you may suffer due to any unlawful use of personal data by parties other than AMICIMI can never be recovered from AMICIMI.

3. Cookies

On this website three types of so-called “cookies” (small parts of information stored on your computer by the browser) are used:

The first type is only temporary and is erased as soon as you close your browser. This type of cookie is only used to allow you to navigate the website.

The second type is used for our website, in order to be able to identify you upon your next visit.

4. Rights of the persons concerned
